KATZ, Reuven Jonah, passed away Feb. 13, 2016, just in time to be with his valentine of 66 years, Catherine Stewart Katz. He led an incredible life. Born in Cincinnati in 1924, he graduated from Walnut Hills High School in 1942 and then attended the University of Cincinnati. He served in the U.S. Army Air Force in WWII. After the war, he was the final student admitted to Harvard Law School without having obtained an undergraduate degree. He graduated from Harvard Law School in 1950. In 1988, University of Cincinnati awarded him his B.A. Degree in Liberal Arts. He began his law career with Paxton & Seasongood and in 1965 opened his own office for the general practice of law. In 1980 he co-founded his cherished Katz Teller Brant & Hild, now Katz Teller where he was honored and privileged to serve as President and Chairman of the Board. He cared deeply for the clients he served and the profession of law. In 1999 the Cincinnati Bar Association granted him the inaugural Lifetime Achievement Award. He served on the board of The Sports Lawyers Association, who also granted him third-ever Award of Excellence. He served as the chairman of the board of the University of Cincinnati Foundation, president of Big Brothers of Cincinnati and The Council of Aging of the Community Chest. He is preceded in death by his brother Morton and his beloved wife Catherine. He is survived by his son Stewart (Ann) and his daughter Sharon. He is also survived by his grandchildren, Ben (Samantha), Paul, Catie (Russ) and great granddaughter Millie. Best Dad Ever!
